1 UTILIZING THE HUNTING PRIVILEGES WILL REQUIRE A HUNTER EDUCATION ID NUMBER. Applications without HUNTER EDUCATION ID NUMBER will result in 'supervision required' status for hunting privileges.

2 License includes privileges of the Wildlife Heritage License.

3 The Wildlife Heritage License includes: fishing in freshwater statewide with hook and line from the bank; fishing in WFF operated Public Fishing Lakes (daily lake permits required); hunting small game, except waterfowl, on WFF Wildlife Management Areas (WMA map/permit required); and shooting on WFF managed shooting ranges.

4 Required to hunt White-Tailed Deer and/or Feral Swine over bait on private land (prohibited on public land, including WMA's). In addition to other required hunting licenses. Mandatory for all hunters – NO EXEMPTION.

5 This license, in addition to appropriate hunting license and Management Area Permit (free) are required for hunting on WMA's. List any WMA Permit(s) needed: _____

6 A 45-day temporary Federal Duck Stamp is now available electronically. Original stamp will be mailed with 30 days. When received, original stamp must be signed in ink across face of stamp.

7 Required to fish gulf reef fish (see regulation page for list of species). Mandatory for all saltwater anglers 16 years and older - NO EXEMPTION. In addition to other required saltwater fishing licenses.
